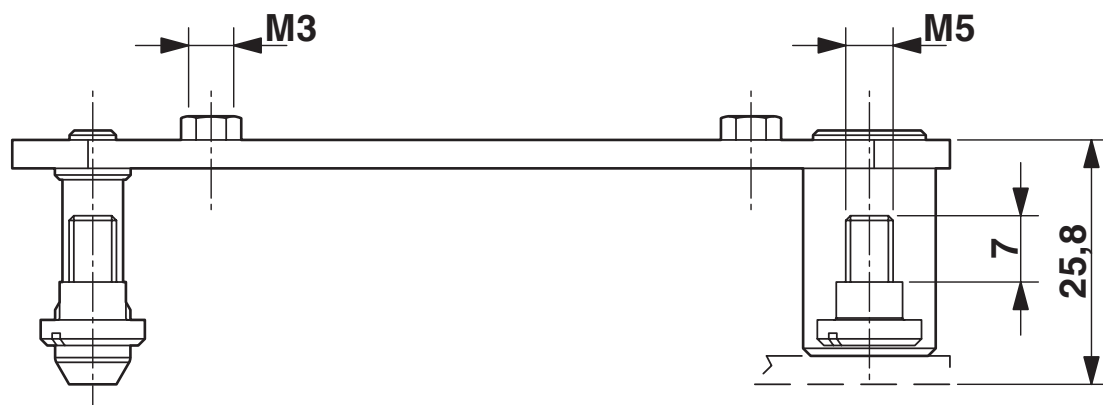


Dimensional drawing
